ASSESSMENT OF CONTRIBUTIONS TO CLAIMS FUNDS

SUPPLEMENTARY FUND

Note by the Director

Summary: There have been no incidents which will or may require the Supplementary Fund to pay

compensation. In the Director's view, there is therefore no need for contributions to be

levied to any Claims Fund.

Action to be taken: Supplementary Fund Assembly

Information to be noted.

1 Introduction

- 1.1 Article 11 of the Supplementary Fund Protocol provides that the Supplementary Fund Assembly shall decide the amount of contributions to be levied, if any. For this purpose, the Assembly shall make an estimate in the form of a budget of the Supplementary Fund's expenditure and income for each calendar year, taking into account the necessity to maintain sufficient liquid funds.
- 1.2 The Supplementary Fund's expenditure consists of:
 - (a) costs and expenses of the administration of the Supplementary Fund in the relevant year and any deficit from operations in preceding years; and
 - (b) payments to be made by the Supplementary Fund of claims and claims-related expenditure.
- 1.3 Expenses mentioned in subparagraph (a) of paragraph 1.2 above have to be met from the General Fund (Financial Regulation 7.1(c)) and expenses with respect to claims and claims-related expenditure as defined in subparagraph (b) above have to be met from a Claims Fund (Financial Regulation 7.2(d)).
- 1.4 As at the date of this document, there have been no incidents which require the Supplementary Fund to pay compensation or claims-related expenses. There is, therefore, no need to make any levy of contributions to any Claims Fund.
