1 <u>Introduction</u>

1.1 In accordance with Rule 10 of the Rules of Procedure of the 1992 Fund Assembly and of the Supplementary Fund Assembly and Rule 9 of the Rules of Procedure of the 1992 Fund Executive Committee, the 1992 Fund Assembly appointed a Credentials Committee consisting of the following five members and their representatives:

1.2 The Credentials Committee met in person on 7 November 2023 under the chairship of Mr Mohd Fairoz Bin Rozali.

2 <u>Examination of credentials</u>

- 2.1 The credentials of delegations of 72 Member States of the 1992 Fund, including States members of the 1992 Fund Executive Committee and of the Supplementary Fund, were examined and found to be in order.
- The Credentials Committee based its deliberations on Rules 9 and 11 of the Rules of Procedure of the 1992 Fund Assembly and on the guidelines given in circular IOPC/2023/Circ.6.
