1 Introduction

2 **Examination of credentials**

2.6 The Credentials Committee expresses its appreciation to Member States for the timely submission of their credentials. - 2.7 The Credentials Committee also wishes to recommend adopting this approach as an established practice for the issuance and submission of credentials. The Credentials Committee further proposes that this practice be formally incorporated in the new circular on credentials and notifications for the IOPC Funds' meetings, which will be issued following the presentation of document IOPC/APR25/1/3.
