1 Introduction

- 1.1 The Credentials Committee presents this revised interim report in accordance with Rule 10 of the Rules of Procedure of the 1992 Fund Assembly.
- 1.2 The Credentials Committee based its deliberations on Rules 9 and 11 of the Rules of Procedure of the 1992 Fund Assembly and on the guidelines given in circular IOPC/2015/Circ.4.
- 1.3 Since the publication of the interim report of the Credentials Committee (IOPC/NOV21/1/2/1) Cameroon submitted its letter of credentials before 11.59 pm Tuesday, 2 November 2021.
- 1.4 The Credentials Committee met remotely at 9.00 am on Wednesday, 3 November 2021 and examined the credentials for the delegation of Cameroon and found them to be in order.
