#### Note by the Credentials Committee

<b>Summary:</b>	The Credentials Committee has examined the credentials of delegations of 1992 Fund Member States and submits the following third interim report.

#### 1 Introduction

- 1.1 The Credentials Committee presents this revised third interim report in accordance with Rule 10 of the Rules of Procedure of the 1992 Fund Assembly.
- 1.2 The Credentials Committee based its deliberations on Rules 9 and 11 of the Rules of Procedure of the 1992 Fund Assembly and on the guidelines given in circular IOPC/2015/Circ.4.
- 1.3 Since the publication of the second interim report of the Credentials Committee (IOPC/NOV21/1/2/2), Kenya and Mauritania submitted their letters of credentials before 11.59 pm on Wednesday, 3 November 2021.
- 1.4 The Credentials Committee met remotely at 9.00 am on Thursday, 4 November 2021 and examined the credentials for both delegations. The credentials of Kenya were found to be in order. In the case of Mauritania, the Credentials Committee noted that the credentials were found not to be in order.
- 1.5 The table listing the 84 Member States eligible to vote in the third ballot is set out in section 2, overleaf.
