Notice of accession to the 1992 Fund Convention by Kiribati, the Cook Islands, Hungary and Ecuador and to the Supplementary Fund Protocol by Hungary

In accordance with Regulation 4.6 of the Internal Regulations of the International Oil Pollution Compensation Fund 1992 (1992 Fund), the Director has the honour to notify Contracting States that instruments of accession to the Protocol of 1992 to amend the International Convention on the Establishment of an International Fund for Compensation for Oil Pollution Damage, 1971 (1992 Fund Convention) were deposited by Kiribati, the Cook Islands, Hungary and Ecuador on 5 February, 12 March, 30 March and 11 December 2007 respectively. The 1992 Fund Convention will enter into force for Kiribati on 5 February 2008, the Cook Islands on 12 March 2008, Hungary on 30 March 2008 and Ecuador on 11 December 2008.

The 102 States which have deposited instruments of ratification, acceptance, approval or accession in respect of the 1992 Fund Convention are listed overleaf.

In accordance with Regulation 4.6 of the Internal Regulations of the International Oil Pollution Compensation Supplementary Fund (Supplementary Fund), the Director has the honour to notify Contracting States that, at the same time as depositing an instrument of accession to the 1992 Fund Convention, on 30 March 2007, an instrument of accession to the Protocol of 2003 to the 1992 Fund Convention (Supplementary Fund Protocol) was deposited by Hungary. The Supplementary Fund Protocol will therefore enter into force for Hungary on 30 March 2008.

The 21 States which have deposited instruments of ratification, acceptance, approval or accession in respect of the Supplementary Fund Protocol are listed overleaf.
