Notice of accession to the 1992 Fund Convention by Mauritania and Niue

In accordance with Regulation 4.6 of the Internal Regulations of the International Oil Pollution Compensation Fund 1992, (1992 Fund), the Director has the honour to notify Contracting States that instruments of accession to the International Convention on the Establishment of an International Fund for Compensation for Oil Pollution Damage, 1992 (1992 Fund Convention) were deposited by Mauritania and Niue on 4 May 2012 and 27 June 2012 respectively. The 1992 Fund Convention will enter into force for Mauritania on 4 May 2013 and Niue on 27 June 2013.

The 111 States which have deposited instruments of ratification, acceptance, approval or accession in respect of the 1992 Fund Convention are listed overleaf.

The 28 States which have deposited instruments of ratification, acceptance, approval or accession in respect of the Supplementary Fund Protocol are also listed overleaf.
