**Notice of accession to the 1992 Fund Convention
by Côte d'Ivoire and the Slovak Republic and to the
Supplementary Fund Protocol by the Slovak Republic**

In accordance with Regulation 4.6 of the Internal Regulations of the International Oil Pollution Compensation Fund, 1992 (1992 Fund), the Director has the honour to notify Contracting States that instruments of accession to the International Convention on the Establishment of an International Fund for Compensation for Oil Pollution Damage, 1992 (1992 Fund Convention) were deposited by Côte d'Ivoire and the Slovak Republic on 8 July 2013. The 1992 Fund Convention will enter into force for Côte d'Ivoire and the Slovak Republic on 8 July 2014.

The 113 States which have deposited instruments of ratification, acceptance, approval or accession in respect of the 1992 Fund Convention are listed overleaf.

In accordance with Regulation 4.6 of the Internal Regulations of the International Oil Pollution Compensation Supplementary Fund (Supplementary Fund), the Director has the honour to notify Contracting States that, at the same time as depositing an instrument of accession to the 1992 Fund Convention, on 8 July 2013 an instrument of accession to the Protocol of 2003 to the 1992 Fund Convention (Supplementary Fund Protocol) was deposited by the Slovak Republic. The Supplementary Fund Protocol will therefore enter into force for the Slovak Republic on 8 July 2014.

The 30 States which have deposited instruments of ratification, acceptance, approval or accession in respect of the Supplementary Fund Protocol are also listed overleaf.
