## Status of the 1992 Fund Convention and the Supplementary Fund Protocol

The Director is pleased to provide the list of the 115 States which have deposited instruments of ratification, acceptance, approval or accession in respect of the International Convention on the Establishment of an International Fund for Compensation for Oil Pollution Damage 1992 (1992 Fund Convention).

The Kingdom of Thailand acceded to the 1992 Fund Convention on 7 July 2017. The Convention will therefore enter into force for this State during 2018, bringing the number of 1992 Fund Member States to 115 by 7 July 2018.

The 31 States which have deposited instruments of ratification, acceptance, approval or accession in respect of the Supplementary Fund Protocol are also listed overleaf.

This information is provided in accordance with Regulation 4.6 of the Internal Regulations of the International Oil Pollution Compensation Fund, 1992 (1992 Fund) and Regulation 4.6 of the Internal Regulations of the International Oil Pollution Compensation Supplementary Fund (Supplementary Fund).
