Notice of accession to the 1992 Fund Protocol by Malaysia, Saint Lucia and Tuvalu

In accordance with Regulation 4.6 of the Internal Regulations of the International Oil Pollution Compensation Fund 1992 (1992 Fund), the Director has the honour to notify Contracting States that instruments of accession to the Protocol of 1992 to amend the International Convention on the Establishment of an International Fund for Compensation for Oil Pollution Damage, 1971 (1992 Fund Protocol) were deposited by the Saint Lucia, Malaysia and Tuvalu on 20 May, 9 June and 30 June 2005 respectively. The 1992 Fund Protocol will enter into force for Saint Lucia on 20 May 2005, for Malaysia on 9 June 2005 and for Tuvalu on 30 June 2005.

The 89 States which have deposited instruments of ratification, acceptance, approval or accession in respect of the 1992 Fund Protocol are listed overleaf.
