Notice of accession to the 1992 Fund Protocol by Estonia, South Africa and Israel

In accordance with Regulation 4.6 of the Internal Regulations of the International Oil Pollution Compensation Fund 1992 (1992 Fund), the Director has the honour to notify Contracting States that instruments of accession to the Protocol of 1992 to amend the International Convention on the Establishment of an International Fund for Compensation for Oil Pollution Damage, 1971 (1992 Fund Protocol) were deposited by Estonia, South Africa and Israel on 6 August 2004, 1 October 2004 and 21 October 2004 respectively. The 1992 Fund Protocol will enter into force for Estonia on 6 August 2005, for South Africa on 1 October 2005 and for Israel on 21 October 2005.

The 92 States which have deposited instruments of ratification, acceptance, approval or accession in respect of the 1992 Fund Protocol are listed overleaf.
