**Notice of Denunciation of the 1971 Fund Convention
by Canada, New Zealand and Indonesia and of
Extension of the Denunciation
by the United Kingdom**

In accordance with Regulation 4.6 of the Internal Regulations of the International Oil Pollution Compensation Fund 1971 (1971 Fund), the Director has the honour to notify Contracting States that, following the deposit of instruments of denunciation, the International Convention on the Establishment of an International Fund for Compensation for Oil Pollution Damage, 1971 (1971 Fund Convention) will cease to be in force for Canada after 29 May 1999, for New Zealand after 25 June 1999 and for Indonesia after 26 June 1999.

The Director also has the honour to notify Contracting States that the Government of the United Kingdom of Great Britain and Northern Ireland extended its denunciation of the 1971 Fund Convention on 15 May 1998 to the territories of Anguilla, Bailiwick of Guernsey, Bermuda, British Indian Ocean Territory, British Virgin Islands, Cayman Islands, Gibraltar, Pitcairn, Henderson, Ducie and Oeno Islands, St Helena and its Dependencies, Turks and Caicos Islands and the United Kingdom Sovereign Base Areas of Akrotiri and Dhekelia on Cyprus.

A list of the 52 Contracting States to the 1971 Fund Convention, including the States which have deposited instruments of denunciation, appears overleaf.
