1 Adoption of the Agenda

Election of the Chairman and two Vice-Chairmen

In accordance with Article 18.1 of the 1992 Fund Convention and Rule 20 of the Rules of Procedure, the Assembly will be invited to elect a Chairman and two Vice-Chairmen who shall hold office until the next regular session.

3 Examination of credentials

In accordance with Rule 10 of the Rules of Procedure, a Credentials Committee consisting of five members shall be appointed by the Assembly on the proposal of the Chairman. The Credentials Committee shall examine the credentials of delegations of Member States and report to the Assembly without delay (document 92FUND/A.11/2).

General review

4 Report of the Director

The Assembly may wish to consider the Director's report on the operations of the 1992 Fund since the Assembly's 10th session (document 92 FUND/A.11/3).

Treaty matters

5 Status of the 1992 Fund Convention and the Supplementary Fund Protocol

The Director will inform the Assembly of progress being made in various States towards accession to the 1992 Fund Convention and to the Supplementary Fund Protocol (document 92FUND/A.11/4)

6 Implementation of the 1992 Civil Liability and Fund Conventions into national law

At its 9th session, held in October 2004, the Assembly instructed the Director to write to all Member States to enquire whether the 1992 Conventions had been fully implemented into their national law. At its 10th extraordinary session, held in February 2006, the Assembly instructed the Director to make further efforts to obtain responses to the enquiries from all 1992 Fund Member States which had not already responded. The Assembly also instructed the Director to contact those States within which the 1992 Conventions had not been implemented into national law as well as States ratifying the 1992 Fund Convention and offer assistance in the preparation of the necessary legislation. The Director will report to the Assembly on this matter (document 92FUND/A.11/5).

7 Application of the 1992 Fund Convention to the EEZ or an area designated under Article 3(a)(ii) of the 1992 Fund Convention

In accordance with 1992 Fund Resolution N°4, States which establish an exclusive economic zone (EEZ) or designate an area under Article 3(a)(ii) of the 1992 Fund Convention before ratifying the 1992 Fund Convention are invited to notify the Secretary-General of IMO accordingly when they deposit their instruments of ratification in respect of that Convention, and States which establish an EEZ or designate an area after ratification are invited to notify the Director accordingly. The Director will report on the developments regarding this issue (document 92FUND/A.11/6).

8 Credentials for 1992 Fund meetings

At its 10th extraordinary session, held in February 2006, the Assembly requested the representatives of those States which had been appointed to the Credentials Committee to consider, in the light of the discussion at that session and in consultation with the Secretariat, the issue of the submission of credentials and related matters and to report to the Assembly's October 2006 session (document 92FUND/A.11/7).

Financial matters

9 Report on investments

In accordance with Financial Regulation 10.2, the Director will submit a detailed report on the 1992 Fund's investments since the 10th session of the Assembly (document 92FUND/A.11/8).

10 Report of the joint Investment Advisory Body

The Assembly will be invited to appoint the External Auditor for the next term. The Assembly will also be invited to consider the procedure for the appointment of the External Auditor for future periods. A document on these issues will be submitted by the Audit Body (document 92FUND/A.11/12).

The Director has invited the organisations having observer status to indicate why they should continue to have such status. A document setting out the observations by these organisations will be presented to enable the Assembly to carry out the review (document 92FUND/A.11/20).

Compensation matters

Reports of the Executive Committee on its 31st-34th sessions

The reports of the Executive Committee's 31st-34th sessions will be presented to the Assembly by the Committee's Chairman (documents 92FUND/EXC.31/2, 92FUND/EXC.32/6 and 92FUND/EXC.33/8).

24 <u>Technical Guidelines on methods of assessing losses in the fisheries sectors</u>

At its 10th extraordinary session held in February 2006, the Assembly instructed the Director to continue to seek the views of interested delegations, including those who had expressed an interest but had so far not provided any input, on the draft Technical Guidelines for experts on methods for assessing losses in the fisheries sectors, for the purpose of making a recommendation to the Assembly on whether, and if so, in what form the Guidelines should be published and whether more precise guidelines should be produced for claimants. The Assembly also instructed the Director to set a final deadline for comments of 1 July 2006 (document 92FUND/A.11/22).

25 Lessons learned from the *Erika* incident

The Director will present a report on what lessons could be learned from the *Erika* incident (document 92FUND/A.11/23).

26 Admissibility criteria relating to claims for costs of preventive measures

At its 32nd session in February 2006, the Executive Committee instructed the Director to carry out an examination of the admissibility criteria relating to claims for costs of preventive measures, in particular for the extraction of oil from sunken vessels, with a view to enabling the Assembly at its October 2006 session to discuss possible alternatives for the existing criteria for admissibility within the framework of the 1992 Conventions. The Director will submit a document on this issue (document 92FUND/A.11/24).

Opening of the Session

Procedural matters

1 Adoption of the Agenda

Election of the Chairman and two Vice-Chairmen

In accordance with Article 16.2 of the Supplementary Fund Protocol and Article 18.1 of the 1992 Fund Convention, the Assembly will be invited to elect a Chairman and two Vice-Chairmen who shall hold office until the next regular session

3 Examination of credentials

In accordance with Rule 10 of the Rules of Procedure, the Director will report to the Assembly on the credentials received from representatives of Members.

General review

4 Report of the Director

The Assembly may wish to consider the Director's report on the operations of the Supplementary Fund since the Assembly's 1st extraordinary session in October 2005 (document SUPPFUND/A.2/2).

Treaty matters

5 <u>Status of the 1992 Fund Convention and the Supplementary Fund Protocol</u>

The Director will inform the Assembly of progress being made by various States towards accession to the 1992 Fund Convention and the Supplementary Fund Protocol (document SUPPFUND/A.2/3).

6 Application of the Supplementary Fund Protocol to the EEZ or an area designated under Article 3(a)(ii) of the 1992 Convention

In accordance with 1992 Fund Resolution N°4, States which establish an exclusive economic zone (EEZ) or designate an area under Article 3(a)(ii) of the 1992 Fund Convention before

ratifying the 1992 Fund Convention are invited to notify the Secretary-General of IMO accordingly when they deposit their instruments of ratification in respect of that Convention, and States which establish an EEZ or designate an area after ratification are invited to notify the Director accordingly. At its 1st ordinary session, the Assembly decided that notifications from States on the establishment of an exclusive economic zone (EEZ) or designation of an area under Article 3(a)(ii) of the 1992 Fund Convention received by the Secretary-General of IMO or the Director in respect of the 1992 Fund should automatically apply in respect of the Supplementary Fund Protocol when the States became parties to that Protocol. The Director will report on the developments regarding this issue (document SUPPFUND/A.2/4).

Financial matters

7 Report of the joint Investment Advisory Body

In accordance with the mandate of the joint Investment Advisory Body, the Body will submit, through the Director, a report on its activities since the 1st extraordinary session of the Assembly (document SUPPFUND/A.2/5).

8 Financial Statements and Auditor's Opinion

In accordance with Article 16.2 of the Supplementary Fund Protocol and Article 29.2(f) of the 1992 Fund Convention, the Director has prepared the Financial Statements of the Supplementary Fund for the financial year 2005. The External Auditor has presented an Opinion on the Financial Statements (document SUPPFUND/A.2/6). The Assembly will be invited to consider the Auditor's Opinion.

9 Joint Audit Body's Report and approval of Financial Statements

The joint Audit Body has produced a Report on its work (document SUPPFUND/A.2/7). The Assembly will be invited to consider this Report and the Body's recommendation that the Assembly approves the Financial Statements of the Supplementary Fund.

10 Appointment of External Auditor

In accordance with Article 16.2 of the Supplementary Fund Protocol and Article 18.6 of the 1992 Fund Convention, the Assembly at its 1st session, held in March 2005, appointed the Comptroller and Auditor General of the United Kingdom as External Auditor of the Supplementary Fund. The Assembly decided that the appointment should be from 3 March 2005 to 31 December 2006, so that the expiry of the terms of office in respect of the three Organisations should coincide. The Assembly decided that the term of office of the External Auditor should thereafter be four years. The Assembly will be invited to appoint the External Auditor for the next term. The Assembly will also be invited to consider the procedure for the appointment of the External Auditor for future periods. A document on these issues will be submitted by the Audit Body (document SUPPFUND/A.2/8).

Contribution matters

11 Submission of oil reports

The Director will report to the Assembly on the situation in respect of the submission of oil reports (document SUPPFUND/A.2/9).

At that 1st extraordinary session, held in October 2005, the Assembly also instructed the Director to proceed with a number of measures which had been proposed to assist States to submit oil reports. The Director will submit a document on this issue (document SUPPFUND/A.2/9/1).

Secretariat and Headquarters matters

12 Operation of the Secretariat

The Director will prepare a document giving information on developments as regards the operation of the Secretariat (document SUPPFUND/A.2/10).

13 Headquarters Agreement

The Director will inform the Assembly on the preparations of a Headquarters Agreement between the United Kingdom Government and the Supplementary Fund (document SUPPFUND/A.2/11).

14 Agreement of co-operation with the International Maritime Organization

The Director will inform the Assembly on the conclusion of a co-operation agreement with the International Maritime Organization (document SUPPFUND/A.2/12).

15 Premises for the IOPC Funds' Secretariat

The Director will inform the Assembly on the current situation in respect of premises for the IOPC Funds' Secretariat (document SUPPFUND/A.2/13).

16 Review of observer status

At the Supplementary Fund Assembly's 1st session, in March 2005, it was decided that intergovernmental organisations and international non-governmental organisations that had been granted observer status in respect of the 1992 Fund should have observer status with the Supplementary Fund, unless the Assembly of the Supplementary Fund decided otherwise in respect of a particular organisation.

At the 1992 Fund Assembly's 7th session, in October 2002, it was decided that a review would be carried out every three years of the list of international non-governmental organisations having observer status in order to determine whether the continuance of observer status for any particular organisation was of mutual benefit. The first such review took place at the 1992 Fund Assembly's 8th session in October 2003, at which time it was agreed that the next review should take place at that Assembly's October 2006 session. The Supplementary Fund Assembly will be informed of the outcome of this review (document SUPPFUND/A.2/14).

Compensation matters

17 <u>Incidents</u>

The Director will report to the Assembly on incidents which will or may involve the Supplementary Fund, if any (document SUPPFUND/A.2/15).

Budgetary matters

18 Sharing of joint administrative costs between the Supplementary Fund, the 1992 Fund and the 1971 Fund

The Assembly will be invited to consider how the joint administrative costs for the calendar year 2007 should be apportioned between the Supplementary Fund, the 1992 Fund and the 1971 Fund (document SUPPFUND/A.2./16).

19 Budget for 2007 and assessment of contributions to the General Fund

20 Assessment of contributions to Claims Funds

The Assembly will be invited to decide on the assessment of contributions to Claims Funds in accordance with Article 11.2(b) of the Supplementary Fund Protocol, if any. The Director will submit a document on this matter (document SUPPFUND/A.2/18).

21 <u>Implementation of STOPIA 2006 and TOPIA 2006</u>

At its 2nd extraordinary session, held in March 2006, the Assembly took note of the Small Tanker Oil Pollution Indemnification Agreement (STOPIA) 2006 and the Tanker Oil Pollution Indemnification Agreement (TOPIA) 2006. The Assembly will be invited to consider a document presented by the Director on the administrative procedures for the indemnification of the 1992 Fund and the Supplementary Fund under these Agreements (document SUPPFUND/A.2/19).

Other matters

Future sessions

In accordance with Article 16.2 of the Supplementary Fund Protocol and Article 19.1 of the 1992 Fund Convention, the Assembly shall hold regular sessions once every calendar year. Tentative arrangements have been made with IMO for a session during the week of 15 October 2007.

23 Any other business

The Assembly will be invited to consider other matters which may be proposed by Member States or by the Director.

24 Address by the outgoing Director

On the occasion of the last session of the Assembly before his successor takes up office on 1 November 2006, the outgoing Director will make a final address to the Assembly.

25 Oath of the Director Elect

Every member of the Secretariat, on taking up his or her duties, shall make and sign an oath or declaration, as set out in Staff Regulation 5. The Director Elect will be invited to make such an oath or declaration before the Assembly (document SUPPFUND/A.2/20).

Adoption of the Record of Decisions

Rule 27 of the Rules of Procedure provides that the Secretariat shall prepare a Record of Decisions of the session. The Assembly will be invited to adopt this Record of Decisions.
