## IMPLEMENTATION OF THE 1992 CIVIL LIABILITY AND FUND CONVENTIONS INTO NATIONAL LAW

#### **Note by the Director**

Summary: The Director provides an up-date on the results of his enquiries as to whether

the 1992 Conventions have been fully implemented into the national law of

Member States.

**Action to be taken:** Information to be noted.

- In document 92FUND/A.10/5 the Director reported on the replies that had been received as of 5 October 2005 from 1992 Fund Member States in response to his letter of 11 April 2005 requesting them to indicate whether the 1992 Conventions had been fully implemented into national law, and to his reminder letter of 19 September 2005 to those Member States which had not responded.
- Due to an administrative oversight, the response from Australia dated 6 May 2005 informing the Director that the 1992 Conventions had been fully implemented in Australian national law was not included in the Annex to that document. Ireland, which had been correctly indicated in the column for States which had implemented the Conventions, had erroneously also been included in the column for not having replied. Both these errors have been corrected.
- 3 Since the publication of the Director's document, responses have been received from Estonia, Latvia, Malaysia, Singapore and the United Arab Emirates. An updated list is at the Annex.

#### 4 Action to be taken by Assembly

The Assembly is invited to take note of the information contained in this document.
