OTHER ADMINISTRATIVE MATTERS

Note by the Director

Summary:	This document deals with the nomenclature and logo to be used in respect of the 1971 Fund, the 1992 Fund and the Supplementary Fund.
Action to be taken:	To consider the nomenclature and logo to be used.

1 Nomenclature

- 1.1 At the 8th extraordinary session of the 1992 Fund Assembly, held in May 2004, the Director submitted that it would be necessary to make a clear distinction between the 1971 Fund, the 1992 Fund and the Supplementary Fund and suggested that the following terminology should be used:

- 1.2 The 1992 Fund Assembly agreed with the Director's proposals that the terminology set out above should be used (document 92FUND/A/ES.8/4, paragraph 3.9.3).
- 1.3 The 1992 Fund Assembly also noted that in certain circumstances it would be necessary or appropriate to refer to the 1971 Fund, the 1992 Fund and the Supplementary Fund together, and agreed that the following terminology should be used: 'International Oil Pollution Compensation Funds' as the full name, and 'IOPC Funds' as the abbreviated expression (document 92FUND/A/ES.8/4, paragraph 3.9.4). The Director has made a proposal to this effect to the Assembly of the Supplementary Fund (document SUPPFUND/A.1/36).
- 1.4 The governing bodies are invited to consider the nomenclature to be used as a result of the establishment of the Supplementary Fund.

2 **Logo**

- 2.1 At its 5th session, the Assembly of the 1971 Fund adopted the logo which has been used by that Organisation since October 1982. The 1992 Fund has used the same logo since the Assembly's 1st session in June 1996. At its 8th extraordinary session the 1992 Fund Assembly agreed with th* Director that it would be preferable if the same logo (in design and colour) were also to be used by the Supplementary Fund (document 92FUND/A/ES.8/4, paragraph 3.9.5). A proposal to this effect has been made to the Assembly of the Supplementary Fund (document SUPPFUND/A.1/36).
- 2.2 The governing bodies are invited to agree that the same logo as the one used by the 1971 Fund and the 1992 Fund should also be used by the Supplementary Fund.

3 **Action to be taken**

The governing bodies are invited to consider:

- (a) the nomenclature to be used by IOPC Funds; and
 - (b) the logo to be used by the IOPC Funds.
