ELECTION OF MEMBERS OF THE JOINT AUDIT BODY

Note by the Director

Summary:	The term of office of the present members of the joint Audit Body of the three Funds will expire at the October 2008 sessions of the IOPC Funds' governing bodies and an election of the members for a new term of office will take place at the October 2008 session of the 1992 Fund Assembly.
	In response to a circular dated 21 January 2008 from the Director calling for nominations, five nominations had been received from 1992 Fund Member States by the deadline of 16 May 2008.
	At its June 2008 extraordinary session, the Administrative Council, acting on behalf of the 1992 Fund Assembly, decided that the candidates whose nominations had been received within the deadline given in the first circular would be automatically elected in October 2008. The Administrative Council further decided that a second circular would be sent by the Director to 1992 Fund Member States calling for further nominations to fill the remaining position and that if more than one candidature was received for this position, an election would take place.
	A second circular was sent to 1992 Fund Member States on 8 July 2008 inviting further nominations to fill the remaining position. By the deadline of 29 August 2008 only one further nomination had been received.
	The term of office of the member of the Audit Body not related to the Organisations ('outsider') with expertise and experience in audit matters, Mr Nigel Macdonald, will also expire at the October 2008 session of the governing bodies when he will at that time have served two terms of office of three years each. At its June 2008 extraordinary session, the Administrative Council, acting on behalf of the 1992 Fund Assembly, endorsed the proposal of the Chairman of the 1992 Fund Assembly that he recommend to the governing bodies at their October 2008 sessions that Mr Macdonald be allowed, as an exceptional measure, to be re-elected for a further and final term of three years in order that the new Audit Body could benefit from the experience that he had gained during his time in

1 <u>Introductio</u>n

- 1.1 In order to increase the transparency of the operation of the IOPC Funds the governing bodies of the 1992 Fund and 1971 Fund decided at their October 2001 sessions to establish a joint Audit Body for the two Organisations. The first election of members of this Audit Body was held in October 2002.
- 1.2 At their sessions held in March 2005, the 1992 Fund Assembly, the Supplementary Fund Assembly and the 1971 Fund Administrative Council decided that there should be a joint Audit Body for the three Funds. The governing bodies further decided that the Supplementary Fund Assembly and the 1971 Fund Administrative Council should not hold elections of the Audit Body Members but instead leave this function to the 1992 Fund Assembly (documents 92FUND/A/ES.9/28, section 19, SUPPFUND/A.1/39, section 31 and 71FUND/AC.16/15, section 8).
- 1.3 The composition and mandate of the joint Audit Body, as decided by the governing bodies at the March 2005 sessions, is set out at Annex I. In this respect, it should be noted that the Audit Body has submitted a revised composition and mandate of the joint Audit Body which will be considered by the 1992 Fund Assembly under a separate agenda item (cf documents 92FUND/A.13/10/1, SUPPFUND/A.4/9/1, 71FUND/AC.23/6/1).
- 1.4 The last election of members of the Audit Body took place in October 2005. Since the mandate of the members of the Audit Body is for three years, the 1992 Fund Assembly will elect a new Audit Body at this session.

2 **Composition of the Audit Body**

2.1 The Audit Body is composed of seven members elected by the governing bodies: one named Chairman nominated by 1992 Fund Member States, five named individuals nominated by 1992 Fund Member States and one named individual not related to the Organisations ('outsider'), with expertise and experience in audit matters, nominated by the Chairman of the 1992 Fund Assembly.



2.2 Of the Audit Body elected in October 2005, two members have only served one term and are eligible for re-election for a second term of three years. These are:

Mr Mendim Me Nko'o (Cameroon) Mr Wayne Stuart (Australia)

- 2.3 In January 2008 the Director issued a circular informing 1992 Fund Member States that nominations of candidates for the six members from 1992 Fund Member States for election to the Audit Body, accompanied by their curriculum vitae, should be submitted to him by 16 May 2008 at the latest. In the circular attention was drawn to the fact that nominations could only be made by 1992 Fund Member States. It was also mentioned in the circular that those present members of the Audit Body who wished to be re-elected for a second term of three years needed to be nominated by a 1992 Fund Member State (Circular 92FUND/Circ.59, 71FUND/Circ.88 and SUPPFUND/Circ.9).
- 2.4 The term of office of the member of the Audit Body not related to the Organisations ('outsider') with expertise and experience in audit matters, Mr Nigel Macdonald, will also expire at the October 2008 session of the governing bodies when he will have served two terms of office.

3 Consideration by the 1992 Fund Assembly at its 13th extraordinary session

3.1 The Administrative Council, acting on behalf of the 1992 Fund Assembly, noted at its 13th extraordinary session, held in June 2008, that the following nominations had been received from Member States by 16 May 2008 (cf document 92FUND/A/ES.13/3):

- 3.2 The Administrative Council decided that the candidates whose nominations had been received within the deadline given in the first circular would automatically be elected in October 2008. The curriculum vitae of these candidates are at Annex II.
- 3.3 The Administrative Council further decided that a second circular would be sent by the Director to 1992 Fund Member States calling for further nominations to fill the remaining position. If more than one candidature was received for this position, an election would take place.
- 3.4 With respect to the one named individual not related to the Organisations ('outsider'), the Chairman of the Assembly put forward the candidature of Mr Nigel Macdonald for re-election and recommended that the Administrative Council decide that, as an exceptional measure, Mr Macdonald be allowed to be re-elected to the Audit Body in October 2008 for a further and final three-year term in order that the new Audit Body could benefit from the experience that he had obtained during his time in office (cf document 92FUND/A/ES.13/3/1).
- 3.5 The Administrative Council endorsed the Chairman's recommendation that the Administrative Council, acting on behalf of the 1992 Fund Assembly, decide that, as an exceptional measure, Mr Macdonald be allowed to be re-elected to the Audit Body in October 2008 for a further and final three-year term. Mr Macdonald's curriculum vitae is at Annex III.

4 Submission of candidatures in respect of the Director's second circular

4.1 On 8 July 2008, the Director sent a second circular to 1992 Fund Member States (Circular 92FUND/Circ.61, 71FUND/Circ.89 and SUPPFUND/Circ.11) requesting nominations to fill the remaining position on the Audit Body. By the deadline of 29 August 2008 only one nomination had been received, that of:

5 Action to be taken by the governing bodies

- 5.1 The 1992 Fund Assembly is invited:
 - to take note of the information contained in this document; (a)
 - to confirm the decision taken by the Administrative Council, acting on behalf of the (b) 1992 Fund Assembly, at its June 2008 session and elect the five members of the Audit Body whose candidatures had been received by the deadline given in the Director's first circular;
 - to elect the remaining member of the Audit Body nominated by 1992 Fund Member States; (c) and
 - to decide, in accordance with the recommendation made by the Chairman of the 1992 Fund (d) Assembly and endorsed by the Administrative Council, acting on behalf of the 1992 Fund Assembly, at its June 2008 session, that Mr Nigel Macdonald as the 'outsider' with expertise and experience in audit matters, as an exceptional measure, be re-elected for a further and final three-year term.
- 5.2 The Supplementary Fund Assembly and 1971 Fund Administrative Council are invited:

ANNEX I

<u>COMPOSITION AND MANDATE OF THE JOINT AUDIT BODY OF THE 1992 FUND, THE 1971 FUND AND THE</u> <u>SUPPLEMENTARY FUND</u>^{<1>}

(As decided by the governing bodies in October 2002 and revised in March 2005 to take into account the entry into force of the Supplementary Fund Protocol)

- 1 The Audit Body shall be composed of seven members elected by the 1992 Fund Assembly: one named Chairman nominated by 1992 Fund Member States, five named individuals nominated by 1992 Fund Member States and one named individual not related to the Organisations ("outsider"), with expertise and experience in audit matters nominated by the Chairman of the 1992 Fund Assembly. Nominations, accompanied by the curriculum vitae of the candidate, should be submitted to the Director at least six weeks in advance of the session at which the election will take place.
- 2 Members of the Audit Body shall hold office for three years, once renewable. Of the first Audit Body to be elected, the term of three of those elected from 1992 Fund Member States shall not be renewable.
- 3 The members of the Audit Body shall perform their functions independently and in the interest of the Organisations as a whole. The members elected from 1992 Fund Member States shall not receive any instructions from their Governments.
- 4 Travel and subsistence expenses of the six members of the Audit Body elected from 1992 Fund Member States shall be paid by the Organisations. The member not related to the Organisations ("outsider") shall be paid travel expenses and an appropriate fee.
- 5 The Audit Body shall:
 - (a) review the effectiveness of the Organisations regarding key issues of financial reporting, internal controls, operational procedures and risk management;
 - (b) promote the understanding and effectiveness of the audit function within the Organisations, and provide a forum to discuss internal control issues, operational procedures and matters raised by the external audit;
 - (c) discuss with the External Auditor the nature and scope of each forthcoming audit;
 - (d) review the Organisations' financial statements and reports;
 - (e) consider all relevant reports by the External Auditor, including reports on the Organisations' financial statements; and
 - (f) make appropriate recommendations to the governing bodies.
- 6 The Audit Body shall normally meet at least twice a year. The Chairman of the Audit Body and the External Auditor may request that additional meetings should be held. The meetings shall be convened by the Director, in consultation with the Chairman of the Audit Body.
- 7 The External Auditor, the Director and the Head of the Finance and Administration Department shall normally be present at the meetings.

- 8 The Chairman of the Audit Body shall report on its work to each regular session of the governing bodies.
- **9** Every three years the functioning of the Audit Body and its mandate shall be reviewed by the governing bodies on the basis of an evaluation report from the Chairman of the Audit Body.

SUMMARY:

John Wren spent his whole career working in the Civil Service until retirement in November 2005. He gained wide experience as an administrator in several government departments. In particular, he has extensive experience on maritime affairs, which he gained while he headed the Department for Transport's policy unit with oversight of all policy matters relating to maritime liabilities, compensation and international maritime law between 1993 and 2005.

He led the UK delegation at the IMO Legal Committee and at the International Oil Pollution Compensation Fund for 12 years. Until 2002 he was also a member of the UK delegation at the IMO Marine Environment Protection Committee.

He headed the UK delegation during the development and negotiation of a number of international instruments and led the UK delegation at six IMO diplomatic conferences. He was also a member of the UK delegations at two other IMO diplomatic conferences.

He was also a member of the UK delegations in several other international fora.

He has chaired a number of international meetings, including the 2nd IOPC Fund inter-sessional Working Group. He had significant input into a wide range of UK legislation to implement a number of national maritime policies and international instruments.

As an acknowledged expert he has made many presentations at international conferences, seminars and workshops dealing with maritime related matters.

Mr. Thomas Johansson was born in 1967 in the town of Norrköping, Sweden. He is a Swedish citizen.

He holds a position as Vice President of the National Board for Consumer Complaints (NBCC) since November 2005. NBCC is a government agency with the task to provide settlement of disputes between consumers and businesses as an alternative to dispute settlements in courts. As Vice President he assists the President with the management of the NBCC and acts as the President's deputy. He is also involved in the dispute settlement process as adjudicator/evaluator of the cases laid before the NBCC and presides during sessions of the NBCC. He is also responsible for the NBCC's administrative department which comprises functions as information, finance and HR.

He received his Master of Laws from Uppsala University, Sweden, in 1993. He has served on various positions within the Swedish judiciary: 1993–1995 as Legal Secretary at the District Court of Linköping, 1995–1996 as Legal Secretary in the Svea Court of Appeal, 1996–1998 as Assistant Judge, and during 1998 as Associate Judge of Appeal.

Prior to taking up his position with the NBCC he held different positions in the Swedish Ministry of Justice, Division for Intellectual Property and Transport Law, between 1998 and 2005. His main responsibilities were in the field of transport law and trademark law. Between 2001 and 2005 he was Principal Legal Adviser/Deputy Director, a position that included supervising the work of other staff within those areas. As of 1 July 2004 he deputised the head of the said division.

Thomas Johansson has represented Sweden in the IMO Legal Committee. He took up work relating to the IOPC Funds during 1999 and participated in meetings of the Funds' governing bodies as Swedish representative from 2000 to 2003. At the 2003 diplomatic conference leading to the adoption of the Supplementary Fund Protocol he was chairman of the drafting committee.

He has also represented Sweden in working groups within the Council of the European Union and within the OECD Nuclear Energy Agency.

Thomas Johansson has been assigned by the Ministry of Justice to produce a report with an analysis of whether Sweden should ratify the International Convention for the Suppression of Acts of Nuclear Terrorism, of 2005, and the 2005 Protocols to the International Convention for the Suppression of Unlawful Acts against the Safety of Maritime Navigation (SUA). The assignment also includes the drafting of the appropriate statutory amendments for the ratification and implementation of these instruments and to translate the instruments.

Thomas Johansson is married with Susanne Kjaersgaard Olsson since 12 May 2007.
