Status of the 1992 Fund Convention and the Supplementary Fund Protocol

The Director is pleased to provide the list of the 115 States which have deposited instruments of ratification, acceptance, approval or accession in respect of the International Convention on the Establishment of an International Fund for Compensation for Oil Pollution Damage 1992 (1992 Fund Convention).

In accordance with Regulation 4.6 of the Internal Regulations of the International Oil Pollution Compensation Supplementary Fund (Supplementary Fund), the Director has the honour to notify Contracting States that an instrument of accession to the Protocol of 2003 to the 1992 Fund Convention (Supplementary Fund Protocol) was deposited by New Zealand on 29 June 2018. The Supplementary Fund Protocol therefore entered into force for New Zealand on 29 September 2018.

The 32 States which have deposited instruments of ratification, acceptance, approval or accession in respect of the Supplementary Fund Protocol are also listed overleaf.

This information is provided in accordance with Regulation 4.6 of the Internal Regulations of the International Oil Pollution Compensation Fund, 1992 (1992 Fund) and Regulation 4.6 of the Internal Regulations of the International Oil Pollution Compensation Supplementary Fund (Supplementary Fund).
