## Status of the 1992 Fund Convention and the Supplementary Fund Protocol

The Director is pleased to provide the list of the 117 States which have deposited instruments of ratification, acceptance, approval or accession in respect of the International Convention on the Establishment of an International Fund for Compensation for Oil Pollution Damage 1992 (1992 Fund Convention).

In addition, the Director has the honour to notify Contracting States that the Co-operative Republic of Guyana and the Republic of Gambia have deposited instruments of accession to 1992 Fund Convention. The dates of accession and entry into force are detailed in the following table:
