ELECTION OF MEMBERS OF THE EXECUTIVE COMMITTEE

Note by the Director

- 1 Under Article 18.8 of the Fund Convention, the Assembly shall elect the Member States to be represented on the Executive Committee.
- 2 The present members of the Executive Committee, elected at the 10th session of the IOPC Fund Assembly, hold office until the end of the 11th session of the Assembly, in accordance with Article 23.1 of the Fund Convention. Members of the present Executive Committee are:

At the time of the 11th session of the Assembly, the IOPC Fund will have 40 Members. Therefore, according to Article 22.1 of the Fund Convention, 14 Members of the Assembly have to be elected to the Executive Committee. Seven Members have to be elected in accordance with Article 22.2(b) of the Fund Convention, and seven Members in accordance with Article 22.2(a). As regards the election of the members under Article 22.2(b), the eleven Members with the largest quantities of contributing oil reported are eligible.

4 On the basis of the reports on contributing oil receipts submitted by 30 June 1988, the Member States are eligible as follows:

- Article 23.2 of the Fund Convention provides that no Member may serve on the Executive Committee for more than two consecutive terms of office, except to the extent that this may be necessary to comply with the requirements of Article 22. Poland, eligible under Article 22.2(a) of the Fund Convention, as well as Finland, the Federal Republic of Germany and the Netherlands, eligible under Article 22.2(b), have been members of the Executive Committee for two consecutive terms.
- According to Rule 41 of the Rules of Procedure, ballots shall first be held for the election of the seven members under Article 22.2(b). Thereafter ballots shall be held for the election of the remaining seven members under Article 22.2(a).
- The information on the 1987 figures for contributing oil receipts is given in Annex I. With respect to those States which had not submitted their reports on the 1987 receipts at the time of the drafting of this document, the 1986 (or, in some cases, 1985) figures are given.
- 8 With reference to the election of members under Article 22.2(a), information on the oil tanker fleets of Member States as at 30 June 1987 is given in Annex II.

Action to be Taken by the Assembly

9 The Assembly is invited to elect new members of the Executive Committee to hold office until the end of the next regular session of the Assembly.
