SUPPLEMENTARY BUDGET 1998

Note by the Director

Summary:	Further to document 71FUND/A/ES.4/5 a more detailed breakdown of the supplementary budget for 1998 is submitted for approval. The revised supplementary budget for 1998 amounts to £251 100.
Action to be taken:	Adopt a supplementary budget for 1998.

1 <u>Secretariat review</u>

1.1 As a result of the review of the Secretariat working methods and the Director's proposal on the revised structure of the Secretariat (document 71FUND/A/ES.4/3/1), it is estimated that the additional costs for 1998 of the proposed changes will be in the region of £211 500, made up as follows:

- The above estimates are based on a gradual recruitment of new staff members during the remainder of 1998. The estimates include the cost of an IT expert to be engaged for a reasonable time to review the Secretariat's IT requirements. They also include an appropriation for a Spanish speaking secretary should the 1992 Fund Assembly, at its 3rd extraordinary session, approve Spanish as a working language of the 1992 Fund.
- 1.3 There may be a need to engage consultants to undertake additional work in connection with the implementation of the proposed changes. An additional appropriation of £20 000 for consultants' fees is therefore included.

2 Extension of the scope of the audit

The External Auditor has not revised his original estimate of £25 000 for the proposed extended scope of the audit (document 71FUND/A/ES.4/4).

3 Other costs

As decided by the 1971 Fund Executive Committee at its 34th session, it was agreed that the 1971 Fund should finance the cost of one extra translator to be employed by the International Maritime Organisation (IMO). An appropriation of £52 400 was approved by the Assemblies for the 1998 budget. Based on new estimates provided by IMO an additional £14 600 will be required. The revised appropriation for 1998 has therefore been increased to £67 000.

4 Sharing of joint administrative costs

As decided by the Assemblies of the 1971 and 1992 Funds, the costs of running the joint Secretariat for 1998 should be distributed with 60% to be paid by the 1971 Fund and 40% by the 1992 Fund (document 71FUND/A.20/30, paragraph 23.1). The increased costs referred above have been distributed accordingly between the two Organisations, except that the additional amount for consultants' fees has been distributed equally between the Organisations.

5 Draft revised budget

A draft revised Budget for 1998, incorporating the increases set out above, is at the Annex.

6 Action to be taken by the Assembly

The Assembly is invited:

- (a) to adopt a supplementary budget of £251 100 for 1998 to cover the increased administrative expenses of the 1971 and 1992 Funds; and
- (b) to approve the revised budget for 1998 as annexed.
