ELECTION OF MEMBERS OF THE EXECUTIVE COMMITTEE

Note by the Director

Summary:
Updated information on contributing oil receipts modifies eligibility for election to Executive Committee as presented in document 71/FUND/A/ES.4/8.

Action to be taken:
Election of seven States to the Executive Committee with effect from 16 May 1998.

In Annex I of document 71FUND/A/ES.4/8, information is given on the 1996 contributing oil receipts as at 20 February 1998. Updated information as at 20 April 1998 is in the attached Annex.

Eligibility for election

- On the basis of the reports on contributing oil receipts submitted by 20 April 1998, Member States will be eligible on 16 May 1998 as shown overleaf (this table replacing that contained in paragraph 9 of document 71FUND/A/ES.4/8).
- 3 Of the 41 States eligible under Article 22.2(a), Algeria, Colombia and Poland are members of the Executive Committee. It will therefore be necessary to elect five more States within this group as members of the Executive Committee from 16 May 1998.
