# APPOINTMENT OF MEMBERS OF THE INVESTMENT ADVISORY BODY

## Note by the Director

- 1 The Assembly decided, at its 1st extraordinary session, to set up an Investment Advisory Body. The mandate of the Body is set out in the Annex to document 92FUND/A.ES.1/22.
- The Assembly considered, in view of the close link that existed between the 1992 Fund and the 1971 Fund, that it would be preferable for the members of the 1992 Fund's Investment Advisory Body to be the same as those of the 1971 Fund's Investment Advisory Body. The Assembly therefore appointed the three members of the 1971 Fund's Investment Advisory Body viz., Mrs M E Beaman Gordon, Mr D Jude and Mr S Whitney-Long, as members of the 1992 Fund's Investment Advisory Body for a term of one year (document 92FUND/A/ES.1/22, paragraph 3.2).
- 3 Two of the present members of the Investment Advisory Body, Mr Jude and Mr Whitney-Long, have confirmed, upon invitation of the Director, that they would be pleased to be proposed for reappointment.
- 4 Mrs Beaman Gordon has left the United Kingdom and will not therefore be able to continue to serve as a member of the Investment Advisory Body after the 2nd session of the Assembly. The Director proposes as her replacement Mr Clive Martin Ffitch, whose autobiographical details are reproduced in the Annex.

# Action to be taken by the Assembly

5 The Assembly is invited to appoint members of the Investment Advisory Body.
