# BUDGET FOR 2004 AND ASSESSMENT OF CONTRIBUTIONS TO THE GENERAL FUND

### **Note by the Director**

Summary:	The need for additional contributions to cover the payments in respect of three incidents which occurred in August and September 2003 is examined.
Action to be taken:	Decide on the levy of 2003 General Fund contributions.

#### 1 Introduction

1.1 Since the issue of document 92FUND/A.8/22 three incidents have occurred which will or may give rise to payments by the 1992 Fund, namely the *Victoriya* (Russian Federation) and the *Duck Yang* and the *Kyung Won* (Republic of Korea). The need for additional contributions to cover payments in respect of these three incidents is considered in this document.

### 2 General Fund assessment

- 2.1 In document 92FUND/A.8/22 the amount of contributions requested to balance the General Fund in 2004 was assessed at £2 523 028, as set out in the table in paragraph 4.1.1 of that document. This figure was arrived at on the basis of the amount required for the administrative expenses and for the estimated incident related expenses set out in Annexes I and III to that document.
- It is estimated that the cost to the 1992 Fund of the *Kyung Won* incident may reach the maximum amount payable for the General Fund, 4 million SDR, which corresponds to £3 488 440. It is further estimated that the *Duck Yang* incident will give rise to payments by the Fund of £1 million, which would be below the maximum amount payable from the General Fund, £3 488 440. As regards the *Victoriya* incident it appears at this stage that the Fund will not be required to pay compensation although some costs will be incurred, estimated at £25 000.
- 2.3 Any payments in respect of the *Kyung Won* incident exceeding the amount payable from the General Fund will be made by means of loans from the General Fund, pending the levy of contributions to a *Kyung Won* Major Claims Fund.

- 2.4 For the purpose of the assessment of annual contributions, it is assumed that any payments in respect of these incidents will be made in 2004.
- 2.5 A revised Annex III to document 92FUND/A.8/22 is at the Annex to this document.
- 2.6 In the light of these considerations the amount of annual contributions needed for the General Fund is estimated as shown in the following table:

- As shown from the estimates in the table above, contributions of £7 036 468 would be needed to balance the budget of the General Fund.
- 2.8 Modifying his proposal set out in paragraph 4.2 of document 92FUND/A.8/22 the Director proposes that the Assembly should fix the levy of contributions to the General Fund at £7.0 million instead of £2.5 million.

## 3 Action to be taken by the Assembly

The Assembly is invited:

- a) to take note of the information contained in this document; and
- b) to decide in respect of the assessment of 2003 contributions to the General Fund.
