INCIDENTS INVOLVING THE 1992 FUND

ERIKA – CLAIMS SITUATION

Note by the Director


Summary: Updated information on the claims situation is given.

Action to be taken: Information to be noted.

1 <u>Claims processing</u>

- 1.1 As at 20 June 2001, 4 960 claims for compensation had been submitted for a total of FFr765 million (£71 million). Of these claims 919 (18%) were presented during the period March June 2001.
- 1.2 Some 3 193 claims totalling FFr327 million (£31 million) had been assessed at a total of FFr206 million (£19 million). Assessments had thus been carried out of 64% of the total number of 4 960 claims received.
- 1.3 One hundred and ninety-four claims, totalling FFr18 million (£1.7 million), had been rejected. Many of the rejected claims are being reassessed in the light of additional documentation provided by the claimants.
- 1.4 Payments had been made by Steamship Mutual in respect of 2 038 claims for a total of FFr82 million (£7.6 million). Most of these payments correspond to 60% of the approved amounts, but some hardship payments made at an early stage were made in full or at higher percentages.
- 1.5 A further 1 761 claims, totalling FFr438 million (£41 million), were either in the process of being assessed or were awaiting claimants providing further information necessary for the completion of the assessment.

1.6 The graph below shows the total number of claims received each month against those assessed and approved during January 2000 - May 2001. It can be seen that the rate at which claims are being assessed has recently started to exceed the rate at which claims are received.





1.7 The table below gives details of the processing of claims in various categories.

- As is shown in the table, there is a significant difference between the various categories of claims as regards the progress made in the claims assessment. In certain categories over 90% of all claims have been assessed and for most categories payments have been made in respect of over 50% of claims. The majority of the claims in these categories were presented fairly early. On the other hand, in the tourism sector only 37% of the claims have been assessed, but of the 2 229 claims in that sector, 658 (ie over 29%) were presented after 1 March 2001. There is still a delay between the time of approving and the time of paying claims, mainly as a result of claimants not having accepted the approved amounts or due to OFIMER not having provided details of advance payments it has made to claimants (cf document 92FUND/EXC.13/3, paragraph 8.2).
- 1.9 The graphs below show the distribution of different categories of claims received prior to and after 1 January 2001. It can be seen that post January 2001 some 77% of all claims related to losses in the tourism sector.
