STATUS OF 1992 FUND CONVENTION

Note by the Director

Summary:	Eighty States have acceded to the 1992 Fund Convention.
Action to be taken:	Information to be noted.

- 1 When the 1992 Fund Convention entered into force on 30 May 1996, nine States were Parties to the Convention and therefore Members of the 1992 Fund. At the time of the 6th extraordinary session of the Assembly held in April/May 2002, 64 States were Members of the 1992 Fund. Since then, the 1992 Fund Convention has entered into force for a further two States, bringing the present 1992 Fund membership to 66. In addition, there are 14 States which have deposited instruments of accession to the 1992 Fund Convention, in respect of which the Convention will enter into force during the coming twelve months. This will bring the number of 1992 Fund Member States to 80 by 31 May 2003, as set out in the Annex.
- 2 Attention is drawn to the three accessions to the 1992 Fund Convention since the 6th extraordinary session of the 1992 Fund Assembly, ie those of Madagascar, Nigeria and Gabon.
- 3 There are still 15 States which were Members of the 1971 Fund when the 1971 Fund Convention ceased to be in force on 24 May 2002 which have not acceded to the 1992 Fund Convention.

Action to be taken by the Executive Committee

- 4 The Executive Committee is invited to take note of the information contained in this document.
