STATUS OF CONVENTIONS

Note by the Director

 Summary:
 Fifty-nine States have acceded to the 1992 Fund Convention. Eleven of the present 41 Member States of the 1971 Fund have denounced the 1971 Fund Convention.

 Action to be taken:
 Information to be noted.

1 <u>1992 Fund Convention</u>

- 1.1 At the time of the April 2000 session of the 1992 Fund Assembly, 43 States were Members of the 1992 Fund. Since then, the 1992 Fund Convention has entered into force for one further State (Dominican Republic), bringing the present 1992 Fund membership to 44. There are 15 States which have deposited instruments of accession to the 1992 Fund Convention, in respect of which the Convention will enter into force during the coming twelve months. This will bring the number of 1992 Fund Member States to 59 by 30 June 2001, as set out in the Annex.
- 1.2 The Executive Committee's attention is drawn to the four accessions to the 1992 Fund Convention since the Assembly's session in April 2000, ie those of Georgia, Antigua and Barbuda, India and Lithuania.

2 <u>1971 Fund Convention</u>

2.1 At the time of the April 2000 session of the 1971 Fund Administrative Council, 42 States were Parties to the 1971 Fund Convention. Since then, the 1971 Fund Convention has ceased to be in force for one State (Panama), bringing the present Membership to 41. There are eleven States - 2 -

which have deposited instruments of denunciation of the 1971 Fund Convention which will take effect during the coming twelve months. This will reduce the number of 1971 Fund Member States to 30 by 30 June 2001, as set out in the Annex.

- 2.2 The Executive Committee's attention is drawn to the two denunciations of the 1971 Fund Convention since April 2000, ie those of Antigua and Barbuda and India.
- 2.3 It should be noted that two 1971 Fund Member States (Kenya and the United Arab Emirates) have acceded to the 1992 Fund Protocol but have so far not deposited instruments of denunciation of the 1969 Civil Liability Convention and 1971 Fund Convention.

3 Action to be taken by the Executive Committee
