REPORT ON CONTRIBUTIONS

Note by the Director

Annual Contributions

- At its 15th session, in October 1992, the Assembly decided to raise £950 000 and £10 million for the 1992 annual contributions to the VOLGONEFT 263 and HAVEN Major Claims Funds, respectively, according to Article 12.2(b) of the Fund Convention, whilst it decided not to levy any 1992 annual contributions to the General Fund. Calculations were made based on these figures, but owing to subsequent amendments to oil receipt figures, invoices were despatched for a total amount of £930 551.32 for the VOLGONEFT 263 Major Claims Fund and £9 845 853.98 for the HAVEN Major Claims Fund. Payment of the contributions was due on 1 February 1993.
- The report on 1992 annual contributions due in 1993 will appear in Schedule I of the Financial Statements of the IOPC Fund for the financial period ending 31 December 1993, to be presented to the 17th session of the Assembly in 1994. Information on the payment of annual contributions, as at 30 June 1993, is given in Annexes I III to this document, as follows:

3 Generally, the response to requests for payments of the 1992 annual contributions has been highly commendable. By 1 February 1993, payment had been made in respect of 75.72% of the amount assessed to the VOLGONEFT 263 Major Claims Fund and 77.72% of the amount assessed to the HAVEN Major Claims Fund. As at 30 June 1993, 98.39% and 98.73%, respectively, of the contributions assessed had been paid. Reminders have been sent to those few contributors who are still in arrears.



With regard to Annex III, it should be noted that interest continues to accrue in respect of the outstanding annual contributions. The figures in the extreme right hand column show the interest accrued up to 30 June 1993 in respect of the outstanding amounts.

Initial Contributions

- 5 In accordance with Article 11.3 of the Fund Convention, initial contributions shall be paid within three months of the date on which the Convention enters into force for a particular State.
- The Fund Convention entered into force for Ireland, Estonia, Republic of Korea, Kenya and Morocco on 17 February 1993, 1 March 1993, 8 March 1993, 15 March 1993 and 31 March 1993, respectively. Initial contributions in respect of these States will be due in 1993. The Governments of Kenya and Morocco have not yet submitted the reports on the quantities of contributing oil received in 1992 and it has therefore not been possible to issue invoices to contributors in these States for initial contributions, if any.
- 7 A report on initial contributions as at 30 June 1993 is given in Annex IV.
