APPOINTMENT OF DIRECTOR

Note by the Secretary-General of IMCO

The Convention provides that the Fund shall have, <u>inter alia</u>, a Secretariat headed by a Director (Article 16) and that the Director shall be appointed by the Assembly of the Fund (Article 18(4)).

The Secretary-General has received from H.E. the Ambassador of the Federal Republic of Germany a communication nominating Dr. Reinhard Ganten as a candidate for the post of Director. The communication, together with its attachment, is annexed to this document. Any further nominations received by the Secretary-General will be circulated in addenda to this document.

The Assembly is invited to give consideration to this nomination.

Har feretary ferend,

I have the honour to refer to the International Convention on the Establishment of an International Fund for Compensation for Oil Pollution Damage, 1971, which was ratified by my Government on December 30th, 1976.

Since there are indications that the said convention will enter into force in the near future the secretariat of the International Oil Pollution Compensation Fund will have to be set up very soon.

According to Art. 36 of the Fund Convention the Assembly will have to be convened by the Secretary General of IMCO and will have to elect the director of the fund (Art. 18 para 4 of the convention).

In this connection I have the honour to inform you that the Government of the Federal Republic of Germany has great interest to nominate Dr. Reinhard Ganten as a candidate for the post of the director of the fund.

At present Dr. Ganten is deputy head of the Transport Law Section of the Federal Ministry of Justice. He took considerable part in drafting the text of the fund

convention and has also participated in the deliberations of the conference which finally adopted the convention.

It further might be mentioned that Dr. Ganten has worked on general subjects related to the prevention of the marine environment from pollution by oil and, on a great number of international meetings, has collected remarkable experience in the field of commercial and transportation law.

Several times he has been head of German delegations to international meetings or chairman of working groups on international conferences. Because of his above mentioned experiences Dr. Ganten has profound knowledge of methods applied in the field of international cooperation and in international organisations. He has management experiences by theoretical studies and practical work entrusted to him.

I have pleasure in enclosing the Curriculum Vitae of Dr. Ganten.

It would be very much appreciated by my Government if you would kindly take note of the proposed candidature of Dr. Ganten and inform the First Assembly of the fund accordingly.
