Status of the 1992 Fund Convention and the Supplementary Fund Protocol

1992 Fund Convention

The Director is pleased to provide the list of the 118 States which have deposited instruments of ratification, acceptance, approval or accession in respect of the International Convention on the Establishment of an International Fund for Compensation for Oil Pollution Damage 1992 (1992 Fund Convention).

In 2020, the 1992 Fund Convention entered into force for the Co-operative Republic of Guyana and the Republic of the Gambia. In addition, the Director has the honour to inform Contracting States that the Republic of Nauru has deposited an instrument of accession to the 1992 Fund Convention. The dates of accession and entry into force are detailed in the following table:
