Whilst handling her cases, she was responsible for legal and expert advice in various areas. Her professional career demonstrates extensive knowledge of maritime claims relating to cargo, collisions, damage to property, deviations, towage, salvage, wreck removal, pollution and personal injury, and valuable experience in the provision of legal advice in respect of contracts (charterparties and bills of lading, among others) and FD&D (Freight, Demurrage and Defence) cases. She has sound knowledge of guarantees given by the P&I clubs and banks, and also of arrests of vessels in various world ports.

RELEVANT ASPECTS OF COMPETENCE

Claims handling and processing

She is responsible for handling incidents. During the supervision of the Hebei Spirit case, which resulted in 127 000 claims being submitted, she was in charge of developing the system for processing payment of claims thus avoiding duplication of payments or fraud. She also implemented in more recent incidents the web-based claims handling system (CHS) and the online claims submission system (CSS).

She was specifically involved in final compliance with the financial obligations of the 1992 Fund during the last stages of the Prestige incident in the Spanish courts. In relation to the Agia Zoni II incident, she was the first person to travel to the spill site to assess the situation and take the first steps for local management of the incident. Recently, she has coordinated efforts for the analysis and understanding of the legal complexities attached to the Bow Jubail case. This has involved discussions on complex legal issues with lawyers specialising in matters that are heard by the highest courts, and a thorough analysis of the Conventions.

Given her experience in the international field, Liliana possesses cultural sensitivity, which is an aspect to be emphasised in claims handling – should a local office be opened or not – since the relationship with the affected country is essential. This is a fundamental quality for proper understanding of the decision-making and reasoning processes of Governments. This sensitivity is demonstrated in her article called "A Question of Culture", published by Britannia News in May 2008.

Strategic Management, Finance and Governance

Liliana has vast experience in high-level negotiations of complex claims that involve large amounts. This means constant contact with governments, local authorities, public and private entities, civil society and the media. In addition to being authorised to pay these claims, Liliana is also empowered under the Financial Regulations to act as signatory in fund investment issues within the delegation of authority granted by the Director. Her assessment of incidents is crucial in decision-making for contribution purposes because incidents determine when a Major Claims Fund must be established. Liliana has therefore played an essential role in defining short and long-term strategies and in general issues that affect proper operation and governance of the organisation dealt with by the joint Investment Advisory Body and the joint Audit Body.

Meetings of the governing bodies and dealings with Member States

Liliana works in close collaboration with the Chair of the 1992 Fund Executive Committee in preparing the meetings of the governing bodies. Together with her team, she prepares and presents the documents relating to the incidents. She has actively participated at seminars, courses and conferences, and in the induction course for delegates and the short course for participants from Member States. She collaborates and is actively involved in multiple projects with both the IMO and non-governmental organisations (CMI, IG, ITOPF, OCIMF, IIDM, ICS and others). She is also responsible for updating claims information on the Funds' website and in their publications. She developed, along with the Director and experts, the publication "Guidelines for presenting claims for environmental damage" given the global interest in the subject.

Knowledge of the Civil Liability and Fund Conventions

In view of her legal career and her years of experience in the P&I Clubs and in the IOPC Funds, she possesses extensive knowledge of the Civil Liability and 1992 Fund Conventions, of the Supplementary Fund Protocol and of the International Convention on Liability and Compensation for Damage in Connection with the Carriage of Hazardous and Noxious Substances by Sea, and of the 1996 HNS Convention and the 2010 HNS Protocol, among others. She has taken part in conferences, courses and seminars to promote awareness of the international liability and compensation regime for pollution damage. At the present time, Liliana is leading the group working on the project to prepare the draft of the Claims Manual relating to the 2010 HNS Protocol, which will be presented at the first meeting of the governing bodies when this latter comes into force. She also collaborated on the workshop on the HNS Convention organised with the IMO in 2018.

Leadership and administration of the Claims department

She leads the department with the smallest number of staff in the Secretariat, optimising its resources in order to provide a high level of service. Liliana and her team handle incidents that the 1992 Fund is currently involved in, they prepare the relevant documents to be presented at the meetings of the governing bodies, and they take part in numerous international forums to promote the regime and the correct implementation of the Conventions and to present specific claims-related matters. She also coordinates the management of local offices. In addition, she is responsible for appointing technical and legal experts. Liliana is very proud to lead a professional team that ensures efficient claims processing.

In 2019, the year when the IMO had empowering women in the maritime community as its theme, Liliana took an outstanding part at the World Maritime Day Parallel Event, in the "minitalks" in the city of Cartagena (Colombia), inspiring new generations as a woman in a leadership position. That same year, because of her status as a Latin American shipping-law woman, she was invited by CMI to its Colloquium in Mexico City as moderator of the panel for women and of the Latin American lawyers' panel and she led the debate on the present status of the Conventions in their countries.

With wide experience and professionalism, Liliana has represented the IOPC Funds at seminars, conferences, virtual talks and workshops at international level, including in: South Korea, Australia, Spain, Portugal, Canada, Oman, Egypt and New Zealand and in several countries of Central and Latin America. Knowledge/professional experience required for the position of Director of the IOPC Funds

Expert knowledge of the 1992 Civil Liability Convention and the 1992 Fund Convention as well as other related conventions; experience of complex legal questions regarding the Funds' activity and ability to understand different legal systems.

Mr Liebert has studied international public law and environmental law in-depth and holds two Masters in those fields (French and English). Together with over 10 years' experience at the IOPC Funds, which includes the analysis and implementation of these conventions, in particular through technical assistance activities, he has a very detailed knowledge of these legal instruments in addition to their practical application. His role at the IOPC Funds and his previous experience have also given him many opportunities to enhance his knowledge of other civil liability conventions as well as other relevant conventions from the IMO (OPRC Convention, MARPOL, etc.). As a member of the Secretariat's management team, he also contributes to all legal discussions connected to the IOPC Funds activity, and his dual training, combined with his experience, provides him with a clear understanding of the various legal systems in which the IOPC Funds operate.

Experience in questions linked to handling compensation claims; ability to assess expert opinions on legal and other questions and to take decisions on this basis.

His 10 years' experience within the IOPC Funds have provided him with thorough knowledge of the applicable criteria for compensation claims, together with the details of incidents involving the IOPC Funds, including their legal and technical dimensions. In addition, drawing from his previous experience, his work with coastal communities in developing countries has provided him with a thorough understanding of the economic and environmental aspects linked to fishing activities and their social and economic impact. His work in the pollution response sector has also given him a technical knowledge, unique for a lawyer, which enables him to accurately analyse pollution response strategies and their effects.

Experience in financial questions, general administration and matters relating to staff; experience in the public sector and good understanding of decision-making procedures and reasoning particular to governments.

With 15 years' experience as head of department in the public relations, operational and commercial fields, he has managerial experience in all its diversity, particularly for the last ten years within an international administration such as the IOPC Funds. Mr Liebert also holds a diploma of higher specialised studies (equivalent to a Master's) in international administration.

Used to high level negotiations; experience in relations with governments at all levels and with public and private bodies; experience in international conferences and intergovernmental meetings.

For the last 20 years, his work has consisted of establishing lasting and effective relationships with governments and organisations representing the oil and shipping sectors. His advocacy work in the field of pollution preparedness and response has often brought him into contact with elected representatives and to work alongside administrative representatives at the highest level. In his role as Head of External Relations within the IOPC Funds, he is involved at the very centre of these matters, which he handles on a daily basis.

As Head of the External Relations and Conference Department, he is regularly called upon to write documents, communicate orally on a wide range of subjects with a diverse audience, including the media, an experience already acquired for a large part in his previous positions.

Throughout his career, Mr Liebert has demonstrated a talent for decision-making, together with an ability to analyse needs and manage change within the organisations where he has worked. With OSRL, in particular, he developed the organisation's visibility in its operational support role for governments in search of technical support, and facilitated a significant increase in the scope of the Singapore branch's commercial activities. At the IOPC Funds, his sense of detail and his determination to always add value to services provided to Member States and other involved parties, enabled him to carry out a complete overhaul of working methods in the External Relations and Conference Department, in under three years, resulting in the redesign of existing tools (website, publications, production of documents and content of training materials).

He also developed new methods to obtain oil reports, leading to a 60% reduction in the number of late reports over this same period.

Spontaneous with excellent people skills, but also attentive to those around him, he is popular with his staff. He is also an excellent team leader showing both empathy and determination, but is at the same time ready to delegate responsibilities and provide other staff members with the opportunity to develop new skills by dealing with other aspects of the organisation's activities.

Mr Liebert is completely bilingual French-English and has a good working knowledge of Spanish.

In addition to his vast international experience, he also has an extensive domestic portfolio covering legal and policy issues including the governance of the Norwegian Maritime Authority. More than 20 years' experience at management level has also provided him with an excellent background for the management of the Secretariat including personnel and financial issues. Holding the position as chair of the 1992 Fund Assembly for the last 10 years has given him a very good insight into all aspects of the operation of the IOPC Funds.
