Status of the 1992 Fund Convention and the Supplementary Fund Protocol

In accordance with Regulation 4.6 of the Internal Regulations of the 1992 Fund and the Internal Regulations of the Supplementary Fund, the Director is pleased to provide the list of 118 States for which the 1992 Fund Convention is in force and the list of 32 States for which the Supplementary Fund Protocol is in force, overleaf.

Developments in 2021

In addition, the Director has the honour to inform Contracting States that the Republic of San Marino and the Republic of Costa Rica have deposited instruments of accession to the 1992 Fund Convention. The dates of accession and entry into force are detailed in the following table:
