## **2025 IOPC Funds Annual Academy**

The Director has the pleasure to announce that the annual IOPC Funds Annual Academy will take place from **Monday, 9 June to Friday, 13 June 2025** at the IOPC Funds headquarters in London.

The week-long programme will cover all aspects of the work of the IOPC Funds and will include practical exercises involving a theoretical incident and the subsequent claims submission process. The Annual Academy, which is supported by the International Maritime Organization (IMO), the International Chamber of Shipping (ICS), the International Group of P&I Associations, INTERTANKO and ITOPF, will also offer participants the opportunity to understand the relationships and common objectives of those stakeholders which are particularly important in tanker incidents where the 1992 Civil Liability and Fund Conventions apply.

Those interested in applying to the Academy are encouraged to read through the section on applicant eligibility and criteria below and apply using the <u>online application form</u>, which can be accessed within the <u>External Relations page</u> of the website. A copy of the provisional programme outline can be found below.

#### **Candidate eligibility and criteria**

- The Academy is open to representatives of **1992 Fund Member States only.** A list of Member States can be found on the <u>Membership page</u> of the website.
- All applications to attend the course must be accompanied by a formal nomination from a government representative.
- The programme will be most beneficial to candidates with an in-depth involvement and interest in the practical application of the 1992 Civil Liability and Fund Conventions. It is expected that Member States nominating a candidate will ensure that this is the case.
- As the programme will be delivered exclusively in English, it is expected that participants are fully conversant in English.
- The Academy is free of charge for the participants, however, any costs incurred must be self-funded or supported by the nominating government.

Accepted candidates will be issued with an official invitation to the Academy from the IOPC Funds Secretariat, however, the Secretariat regrets that it is unable to help participants with obtaining entry visas to the United Kingdom.

All interested parties are encouraged to apply with a supporting nomination letter as soon as possible, as there are a limited number of places available. Generally, places are allocated on a first come, first served basis and are restricted to one place per Member State. Should the number of nominations received exceed availability, the Secretariat may select candidates by considering their profile and a reasonable balance of geographic representation.

#### **How to apply**

Candidates should submit their nomination via the <u>online application form</u> within the <u>External Relations page</u> of the website by **Friday, 2 May 2025**. You will be requested to:

- complete the online application form;
- upload a nomination letter by the nominating government addressed to the Director of the IOPC Funds, which should briefly outline the reasons why the candidate is interested in the Academy and how the candidate will benefit from participating; and
- upload a brief curriculum vitae no longer than two pages.

You will not be able to submit the application form without the required accompanying documents.
