Status of the 1992 Fund Convention and the Supplementary Fund Protocol

In accordance with Regulation 4.6 of the Internal Regulations of the 1992 Fund and the Supplementary Fund, the Director is pleased to provide the following lists:

- 122 States for which the 1992 Fund Convention is currently in force
- 33 States for which the Supplementary Fund Protocol is currently in force

Developments in 2025

The Director is pleased to report that the 1992 Fund Convention entered into force for Iraq on 5 August 2025, bringing the total number of States for which the Convention is currently in force to 122.

Furthermore, the Director has the honour to inform Contracting States that the Solomon Islands have deposited instruments of accession to both the 1992 Fund Convention and the Supplementary Fund Protocol on 27 November 2025. These instruments will enter into force for the State on 27 November 2026.
